Annual Performance Report for Ann Jerkins-Harris Academy of Excellence SY 2022-2023 DATA

The North Central Ohio Educational Service Center (NCOESC) community school sponsorship seeks to develop positive relationships and support school leaders/developers who provide high-quality educational experiences for students throughout the state of Ohio. Every year, the NCOESC provides an Annual Performance Report for each of its sponsored community schools. The following report provides an overview of the school and a summary of its performance in academics, fiscal, organizational/operational, and adherence to legal compliance over the most recent school year and the term of the sponsorship contract.

NCOESC provides rigorous oversight, monitoring, and technical assistance to our sponsored schools with processes and protocols that align with standards developed by the National Association of Charter School Authorizers and the state of Ohio's Sponsor Performance Review. NCOESC collects data from its sponsored schools throughout the year to determine specifically the extent to which each school is performing in the following four areas: academic, fiscal, operational/organizational and legal compliance. Data gathered through a variety of means reviewed and analyzed to determine school's performance includes the following:

- Site visits to schools, including walkthroughs while school is in session with findings reported to the governing authority at meetings;
- Monthly financial reviews;
- Attendance at community school governing authority board meetings;
- Ongoing reviews of assessment data highlighting student achievement and growth;
- Ongoing reviews in the areas of state and federal compliance, academics, special education, operations, and finance;
- Ongoing technical assistance delivered by trained and experienced staff; and,
- Reviews of reports electronically submitted to the NCOESC compliance-tracking database.

ACADEMIC SUMMARY

(Did not meet Expectations)

Ann Jerkins-Harris Academy of Excellence (AJHAE) continues to work diligently to support students in reaching academic goals. The Achievement component represents whether student performance on state tests met established thresholds and how well students performed on tests overall. While Ann Jerkins-Harris Academy of Excellence (AJHAE) out performed or performed the same with two comparative schools, the Academy has identified academic areas for improvement in mathematics, language arts, attendance and chronic absenteeism. AJHAE has been identified as a comprehensive support and improvement school. They continue to work collaboratively with SST1 for their school-wide academic improvement initiatives. The academy did not meet any of the state thresholds of students scoring proficient or higher on each of Ohio's State Tests disaggregated by grade level and subject.

AJHAE's chronic absenteeism percentage is slightly lower than the state, however, continuing to reduce that percentage should remain a focus for school improvement.

The Early Literacy component needs significant support to meet state standards. The measures included in this component are proficiency in Third Grade Reading, Promotion to Fourth Grade, and Improving K-3 Literacy. Fourth Grade promotion percentage was reported "not counted" on the report card. The academy's 3rd grade literacy proficiency along with moving students from "off track" to "on track" was reported as 75% still "off track" and continues to be a need of focus for AJHAE's school improvement plan for improving academic measures.

Regarding non-academic performance there are no concerns at this time. Thank you to school leadership and to AJHAE's Governing Board for your commitment and dedication to providing great oversight and great leaning opportunities for the students at Ann Jerkins-Harris Academy of Excellence.

FISCAL SUMMARY

During the 2022-23 school year, AJHAE worked diligently to adhere to all compliance expectations set forth in their sponsorship contract with North Central Ohio Educational Service Center and with all rules and law for community school operations. AJHAE submitted documentation for evidence of adherence to all rules and laws to the sponsor through Epicenter, which in turn, the sponsor submits to the Ohio Department of Education Department of School Choice.

We thank AJHAE for your continued efforts towards compliance with all rules & laws and for getting all documentation uploaded in a timely manner. As the sponsor of AJHAE, we will continue to work collaboratively and strive to meet a goal of zero non-compliant items for the 2023-24 school year. In addition, as more requirements are identified and required by The Ohio Department of Education, we will continue to work collaboratively with AJHAE to ensure compliance with all rules and laws related to school operation in accordance with the Ohio Department of Education.
